School Year 2020-2021 Tuition Assignment Policy
Tuition Rates *frozen at 2019-2020 Rates*

Tuition will first be applied to each school family at the Full Tuition Rate. Then each school family who is already registered at St. Joseph Church for over 6 months and who qualifies as an ACTIVE parishioner family per the criteria below will receive the Active Parishioner Discount. This will be reflected as a discount applied in FACTS. The Active Parishioner tuition rate is equivalent to the former In-Parish tuition rate. If the family does not meet the criteria as Active, then the tuition rate will remain at the Full Tuition Rate.

IF, however, during the course of the school year, a family has been registered at St. Joseph Church for at least 6 months and meets the criteria for Active status, then their tuition will be prorated down to the Active Parishioner Tuition Rate.

ACTIVE PARISHIONER CRITERIA

Being an active parishioner, first and foremost, has everything to do with being a disciple of Christ in our parish. In order to encourage the development of discipleship and to qualify for the Active Parishioner Discount, the following criteria must be met:

- 1.) Worship at the Holy Mass every Sunday according to the Lord's Commandment to "*keep holy the Sabbath*", and worship on Holy Days of Obligation as mandated by the authority of the Church.
- 2.) Help provide for the needs of the Church by giving oneself in active charity to our parish, the local community of Christ's disciples. This is accomplished by acts of self-sacrifice that take the form of the gifts of one's time, personal presence, involvement, and talents, as well as financial support of the parish.
- 3.) Be attentive daily in prayer and in person to the needs of our brothers and sisters in Christ, to our neighbors, to the poor, the vulnerable, the sick, and any in need that circumstances present to us in our daily lives.
- 4.) Seek daily to know Christ more deeply and personally by learning more about the Teaching of Jesus Christ as taught by the Holy Catholic Church and laboring daily to be obedient to Jesus and His Gospel Truth, who reveals Himself through the Word and Sacrament in the work and life of His Pilgrim Church on earth.

More Questions and Answers

Who needs to sign up?

Everyone! In order to maintain one tuition billing system, we need all families, regardless of payment plan, to register with FACTS Management. A family will not be considered registered for 2020-2021 until enrollment in FACTS Management is complete. New families should enter their family information by May 10, 2020, and returning families should verify their account information before the first scheduled payment date on their selected payment plan. The sign-up site will be available for new and returning families beginning March 20, 2020. Deadlines for payment plans begin May 20, 2020 depending upon which payment plan is selected. Please review the information on the sheet entitled "Payment Plan Options".

Does it cost anything to register?

Yes, and no. If a family is entering a payment plan that is anything other than a one-time payment, there is a fee. All monthly payment plans whether for 10 months or 12 months will be assessed a \$45 enrollment fee.

The only plan not requiring an enrollment fee is the single upfront payment. Plus, if you pay upfront by June 15, 2020, there is a \$100 discount for tuition for K - 8. (There is no discount for PreSchool.) All upfront payments must be made by August 15, 2020.

Are the fees the same as last year?

Yes. If you sign up for a monthly plan in the FACTS Management system, a fee of \$45 is assessed which goes to the FACTS Management system. The one-payment plan is free of enrollment charges.

How do families apply for financial aid?

Financial aid applications are found on the same enrollment site for FACTS Management under the tab "Grant & Aid". The application is available on March 1, 2020. The fee for the application is \$35.

What is the deadline for financial aid applications?

April 30, 2020

To whom do I talk to if I ever have any payment problems?
